



Student and Accident Insurance Network (S.A.I.N)

If you are injured while participating in a covered school activity and need medical treatment, you may be eligible for benefits under Coast CCD-Coastline College's Student Accident Insurance Policy.

To start a claim:

1. The student and the designated College official must complete and sign the Student Accident Claim Form within 90 days of injury.
2. The completed form is emailed to SAIN@anthem.com for processing. Once approved, Anthem Blue Cross will assign a designated claim number (N#).
3. Medical providers should use the assigned claim number (N#) when submitting bills for covered medical services to Anthem Blue Cross.

Student-Athlete Insurance Network (SAIN) - Excess Coverage*
